



The Ohio Secretary of State's business registrations file showed that The Kroger Co. was registered as a Corporation on April 3, 1902, under the file registration number 14931.

The company was founded in 1883 and was incorporated in 1902.

The company's common stock is traded on the New York Stock Exchange (NYSE) under the symbol "KR". As of March 22, 2023, there were 25,062 shareholders of record. As of April 24, 2023, those shareholders identified by the company as beneficially owning 5% or more of the outstanding shares were: The Vanguard Group (11.51%); BlackRock, Inc. (9.2%); and Berkshire Hathaway Inc. (7.0%). As of the same date, officers and directors as a group beneficially owns 1.4% of the outstanding shares.

#### ANNOUNCED MERGER AND ACQUISITION:

On October 13, 2022, the company, Albertsons Companies, Inc., a Delaware corporation (Albertsons), and Kettle Merger Sub, Inc., a Delaware corporation and wholly owned subsidiary of Parent (Merger Sub), entered into an Agreement and Plan of Merger, pursuant to which Merger Sub will be merged with and into the Albertsons, with the Albertsons surviving the Merger as the surviving corporation and a direct, wholly owned subsidiary of the company. The transaction is expected to close in early 2024.

CRIMINAL PROCEEDINGS

Ralphs and its parent company were charged with overcharging customers, false advertising and false labeling after an undercover operation by Los Angeles county officials.

The multicount criminal case, filed by the Los Angeles city attorney's criminal branch, said Ralphs overcharged on prepackaged and weighed products such as fried chicken, bulk coffee, salads and fish. The chain was fined for similar violations in 2008 and 2009. Ralphs and parent company Kroger Co. could face fines and penalties of up to \$256,000 each.

The lawsuit lists 14 counts of false and misleading advertising, 18 counts of unlawful computation of value, nine counts of selling prepackaged commodities in less quantity than represented and 18 counts of false labeling. All charges are misdemeanors.


